In local flying news, the KWJF runway project is nearly finished...Yay! I did fly from the new asphalt on my last VC-180 proficiency flight and I must say they did a good job on the runway proper, though the main taxiway was just patched and re-sealed. There are still visible fissures, but they pose no hazard to taxi (yet). Speaking of taxiways, other than the main parallel one, which is still called "Alpha", all the others have been re-designated as "Alpha 1, Alpha2" etc., starting at the Runway 24 end.
